As Heritage Christian School has a financial obligation to its employees, students shall be considered enrolled for one entire school year. Tuition will be calculated on the basis of the entire year; therefore, no reductions will be made for vacations or school holidays. If a student leaves the school for any reason or enters after the school year has begun, charges will be pro-rated according to the actual number of days enrolled. All withdrawals, whether before the school year begins or during the year, must be made in writing and shall be effective when such notice is delivered to the school. Families are required to re-apply each year. All applications are reviewed and approved or declined before a student is re-enrolled.
